

Alert Notifications in Prologic Invoice Software

The Prologic Invoice Software provides a comprehensive system for generating notifications and alerts to taxpayers to ensure compliance with GST regulations. These alerts are integrated into the software and accessible through both email and push notifications.

#	Alert	Usage
1	Upcoming Filing Deadline Reminder	Notification sent via email and push to remind users of upcoming GST filing deadlines.
2	Filing Deadline Missed	Alert sent via email and push notifying the user of missed GST filing deadlines.
3	Successful Return Submission	A confirmation notification was sent for the successful submission of GST returns.
4	Return Submission Failed	A notification was sent indicating a failure in GST return submission with suggested corrective actions.
5	Payment Due Tomorrow	A reminder was sent via email and push, notifying the user of a pending GST payment due the next day.
6	Payment Due Today	An alert was sent reminding the user of a GST payment due on the current day.
7	Overdue Payment Alert	Notification was sent for overdue GST payments along with penalties or applicable interest.
8	Successful Payment Confirmation	Confirmation is sent to the user for successful GST payment processing.
9	E-Way Bill Expiry Alert	A notification was sent for expiring E-Way Bills with action items to extend or close them.
10	E-Way Bill Generated Successfully	Alert confirming the successful generation of an E-Way Bill.
11	IRN (Invoice Reference Number) Generation Success	A notification was sent to confirm the successful generation of an IRN.
12	IRN Generation Failure	An alert was sent in case of failure in IRN generation, with reasons and corrective steps.
13	Annual Return Filing Reminder	Email and push notifications are sent to remind users about annual GST return filings.

14	GSTIN Cancellation Notification	A notification was sent alerting users about the cancellation of GSTIN, along with possible resolution steps.
15	Taxpayer Profile Update Reminder	An alert was sent, prompting users to update their taxpayer profile information.
16	Account Activity Alert (Suspicious Activity Detected)	Notifications sent to alert users of suspicious activity detected in their accounts.
17	Quarterly Return Reminder for Composition Scheme	A reminder was sent for quarterly GST return filings for composition scheme users.
18	Switch from Monthly to QRMP Scheme Reminder	An alert was sent notifying users of the option to switch from the monthly to the QRMP scheme.
19	Switch from QRMP to Monthly Scheme Reminder	Notification sent to remind users of the option to revert from QRMP to the monthly scheme.
